Summer 2010 Day Camp Policies and Procedures

HOW DO I REGISTER MY CAMPER?

- Complete a Camp Registration Form for each camper (*Registration opens Feb. 5, 2010 available online at www.gshnj.org/camps.)*
 - Be sure to list 1st and 2nd choices, where applicable, which will increase our ability to serve you
 - Campers may request to be placed with one friend. Friends must register for the same program/session, be of the same age/grade and must request each other. Requests will be honored if space is available in desired program
 - A \$30 transfer fee will be charged to change programs or sessions

OK, I'VE FILLED OUT MY FORM, NOW WHAT?

- Camper registration forms are accepted by MAIL only and will be processed as they are received
Registrations forms, with non-refundable deposits for each session, should be mailed to the following address:

WHAT KIND OF PAYMENTS DO I NEED TO MAKE?

- A \$60 non-refundable deposit for each session must accompany each form (even if you are applying for financial aid)
 - Deposits are payment toward your total balance due
 - You can pay by check, money order, or credit card
 - Checks or money orders should be made payable to GSHNJ
(Please put your camper's name on the face of the check or money order)
 - We reserve the right to collect on and charge for checks that are returned for non-sufficient funds

WHAT'S NEXT?

A confirmation packet including Health Forms and an invoice will be e-mailed to you or you may request that a copy be mailed to you

- The required camp forms from the camp confirmation packet must be filled out and returned by **May 17, 2010**
 - All accounts must be paid in full by **May 17, 2010**
 - Please note: If you register after May 17th, full payment is due with registration and forms and must be returned immediately

WHAT IF I WANT A REFUND?

- A full refund will be given for an program cancelled by Girl Scouts Heart of New Jersey
(GSHNJ reserves the right to cancel any program)
 - **Prior to May 17, 2010:** written refund requests will be honored, minus the \$60 non-refundable deposit per session
 - **After May 17, 2010:** no refunds, except for requests due to a death in the immediate family or a medical necessity
(a written note from a physician must accompany the request), minus the \$60 non-refundable deposit per session
 - There will be no refunds or credits for no-show, partial sessions, adjustment difficulties, early departure, late arrival, schedule conflicts, etc.
 - Any approved refunds will be processed by September 1, 2010
